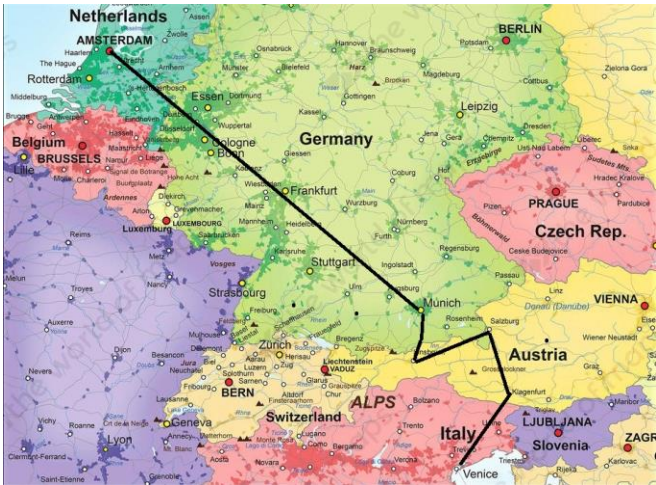
Amsterdam – Munich – Innsbruck – Salzburg – Lake Millstatt – Venice

Day 01
Aug 21, Fri: VANCOUVER – AMSTERDAM
 Departure for Europe

Day 02
Aug 22, Sat: ARRIVE AMSTERDAM
 After arrival – transfer to hotel and dinner (D)

Day 03
Aug 23, Sun: AMSTERDAM
 Morning sightseeing of the capital of the The Netherlands with a short canal boat cruise and then visit to the famous Ajax Stadium – afternoon game against local team (B,D)

Aug 24, Mon: AMSTERDAM – MUNICH
 Today we travel by train to Bavaria and upon arrival in Munich, transfer to our hotel (B,D)

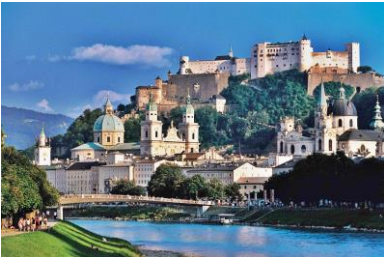
Day 05

Day 08
Aug 28, Fri: INNSBRUCK – SALZBURG – LAKE MILLSTATT / SOUTHERN AUSTRIA
 Travel to Salzburg, Austria and tour of the town, where Mozart is born, enjoy a stroll through the picturesque Getreidegasse and then we we explore the Salt Mines of Hallein before we travel across the Alps to Southern Austria (B,D)

Day 09
Aug 29, Sat: LAKE MILLSTATT / SOUTHERN AUSTRIA
 The province of Carinthia is full of lakes and charming villages; our base camp will be on Lake Millstatt, we have an orientation and a practise session and we also take a boat trip on the scenic lake (B,D)

FACTS YOU SHOULD KNOW!

RESERVATIONS AND PAYMENT:

A deposit of \$300 per person is required at the time of making a reservation on the Special Travel International (hereafter called STI) tour. A second payment of \$ 300 is due by November 30, 2019. A third payment of \$ 500 is due by January 15, 2020. A fourth payment of \$ 900 is due by March 15, 2020. The final payment is due by May 15, 2020. Travel documents will be sent to you approximately 14 days prior to your trip departure, provided full payment has been received.

TOUR PRICES:

All tour prices for land arrangements are based on rates effective at the time of printing and are expected to be in effect at the time of departure. Should these rates change, it may be necessary to surcharge the price of your vacation. Should the tour price increase by more than 10%, the passenger shall have the right to cancel within seven days of notification without penalty.

CANCELLATION AND REFUNDS:

Notice of cancellation must be made in writing. The effective cancellation date is the date when written notification is received by STI.

The following scale of charges will apply when cancellation is received prior to departure.

STI acts only as an agent in securing all services related to the tours described in this brochure, including transportation, sightseeing and accommodation. STI shall not be responsible or liable for any loss, cost, damage,

injury, delay or expense arising from the use of any conveyance, accommodation or service or from acts of God, strikes, weather, quarantine, accidents, sickness, government regulations, insufficient documents and any loss expense resulting from the above contingencies shall be borne by the tour member. In the event it becomes necessary or advisable for the comfort of the passenger, or for any reason whatsoever, to alter the itinerary or arrangements, such alterations may be made without penalty to the operators.

Additional expense, if any, shall be borne by the passenger. The right is reserved to withdraw any or all tours should conditions warrant, and also to decline to accept or retain any passenger as a member of the tour. In such instances, full or equitable amounts will be refunded.

INSURANCE:

STI recommends that each tour participant has health, cancellation, interruption, accident and baggage insurance for the duration of his/her travel, (in case of insurance not being included in the tour price).

TRAVEL DOCUMENTS:

It is entirely the passenger's responsibility to possess whatever documents and VISAS are required by the law of the countries visited on the tour.

AIRLINE RESPONSIBILITY:

Any airliner carrier providing transportation in connection with these tours is not to be held responsible for any act, omission or event during the time the passenger is not on board its planes or conveyances. The passenger contract in use by the airlines concerned, when issued, shall constitute the sole contract between the airline and the purchase of these tours and/or passenger. Similar responsibility as noted applies to all types of carriers, including car rental companies.
